There will be added to the Customer's bill, as a separate item, an amount equal to the proportionate part of any license, occupation, franchise, or other similar fee or tax now or hereafter imposed upon the Company by any municipality or any other governmental authority, whether imposed by ordinance, franchise, or otherwise, in which the fee or tax is based upon a percentage of gross receipts, net receipts, or revenues from the sale of electric service rendered by the Company to the Customer. Bills will be increased the proportionate amount only in service areas where such tax is applicable. See Tax Adjustment Rider.

1.7. CONDITIONS OF SERVICE:

- 1.7.1. Voltage, phase and frequency of energy supplied will be as approved by the Company.
- 1.7.2. Service will be furnished for the sole use of the Customer and will not be resold, redistributed or submetered, directly or indirectly.
- 1.7.3. Service will be supplied through a single meter unless otherwise authorized by the Company. The point of delivery and location of the meter will be at the building wall unless otherwise specifically designated and approved in advance by the Company for each exception.
- 1.7.4. If this schedule is used for service through a single meter to multiple-family dwellings within a single building, each kWh block will be multiplied by the number of dwelling units served in calculating each month's bill.
- 1.7.5. Welding, X-ray, or other equipment characterized by severe or fluctuating demands, will not be served.
- 1.7.6. Intermittent or seasonal service will not be provided.
- 1.7.7. Bills for service will be rendered monthly. At the option of the Company, however, the meters may be read bimonthly with the bill for the alternate month based upon an estimated kWh consumption.
