STANDARD PRICING SCHEDULE:

LOW INCOME ASSISTANCE PROGRAM SCHEDULE – LIAP

DESCRIPTION:

This Low-Income Energy Affordability Program (the "Program") is provided to eligible Residential customers in the service territory of the Company. The Program will be initiated upon the PUD approval of this Schedule and final order in PUD201800133.

SPECIAL CONDITIONS OF SERVICE:

This rider shall be applied to all individually metered residential customers who are qualified by the Oklahoma Department of Human Services (DHS), and who are certified to the Company by the DHS for payments under the federally funded Low Income Home Energy Assistance Program.

FUNDING:

The Program shall be initially funded by the Company prior to recovery by the creation of a regulatory asset. The program will be a four year pilot program and will be limited in cost for each year to \$50,000 in total. Once payments have initiated they will be amortized by collections from all rate classes including Residential non-participants at the end of the first year of the program. The funding fee per bill to non-participants will be based on the Total Annual Program Fund estimated costs allocated to all rate classes based on the percentage of each rate class's share of total revenue requirements in the approved class cost of service in PUD2018100133 and will be adjusted annually for excess or shortfall. The first adjustment to recover funding will take place one year after the Rider is commenced. The Funding fee to Residential non-participants will be limited to a maximum of 55ϕ per month.

PROVISIONS:

Low income Residential ratepayers, once qualified, can receive a reduction in their monthly electric bill for a total of six months out of a 12 month period (3 months of December, January, and February and 3 months of June, July, and August) of \$10.00 each month. Once qualified and confirmed by the Company through a contact letter, qualified customers whose household income is at or below 135% of the Federal Poverty Level ("FPL") would receive the LIAP credit of \$10.00. Those qualified ratepayers who are below 100% of FPL would receive a \$30 a month credit in place of the \$10 credit for each of the 6 months. A qualified low-income residential ratepayer shall be permitted to carry forward a balance of their LIAP credit to the following month(s) in cases when the total customer bill is less than the LIAP credit for the current month..
