

# Arkansas Residential Weatherization Program

## **Arkansas Electric Customers Program Information & Application**

### **Information**

Liberty is offering a new weatherization energy efficiency program to qualified residential electric customers in Arkansas. This program has been approved by the Arkansas Public Service Commission for a limited number of homes. Customer participation in Liberty's Arkansas Residential Weatherization Program is strictly voluntary.

#### Why is Liberty making this offer?

The program is designed to provide energy efficiency upgrades to participants, thereby decreasing their energy usage and expense. The program is intended to improve comfort and reduce energy costs by upgrading the thermal envelope and appliances in targeted households.

#### How does it work?

For a limited number of homes, an auditor approved by Liberty will perform an energy audit to determine if a home qualifies for the program. If a home qualifies, a contractor approved by Liberty will install the upgrades chosen by the guidelines of the program. The chosen upgrades are selected by the auditor based on cost-effectiveness tests and are subject to financial limits per home. The upgrades can include attic insulation, air sealing, and duct sealing. Customer will be eligible to receive free or significantly reduced advanced thermostats, water heater wrap, smart power strips, low faucet aerators, and low flow showerheads. Customers must reside in an individually metered single family residence.

#### How can I be considered for the program?

- Complete the following application form indicating your interest in being contacted in the future.
- Each year that the program is approved, a list of potential participants will be selected.
- Potential participants may be contacted by a Liberty employee or a Liberty contractor, who will determine whether the
  participant's home could potentially qualify, and for what improvements.
- If a participant's home qualifies, a contractor will organize a time to visit and perform the upgrades that the program guidelines
  have deemed cost-effective for your home.

Home audits are available on a "first-come, first-served" basis to Arkansas homeowners and renters who are customers of Liberty and have expressed an interest in the program.

Application does not guarantee inclusion into the program, nor does it guarantee which, if any, upgrades a home can qualify for. These decisions are the sole choices of Liberty and its contract partners for the program.

The only way to determine eligibility for the program is to apply for the program.
