- Lighting (fixtures, lamps and controls)
- HVAC (unitary systems, chillers, and variable frequency drives)
- Food service equipment

Custom

Our custom rebates are available for site-specific, multi-measure, and other complex projects requiring more in-depth energy efficiency upgrades not included in the prescriptive offerings. Custom projects must be able to show specific and verifiable energy savings. Liberty will determine the incentive levels on a project-by-project basis. Typical custom measures include the following:

- Energy management systems
- Compressed air systems
- Whole-building solutions

Program requirement information

- All projects require preapproval prior to ordering, purchasing, or installing new equipment. Please check program requirements with your contractor or Liberty representative.
- Commercial and industrial electric customers may receive up to \$20,000 in rebates per program year. This cap is imposed by your federal tax ID.
