11. SPECIAL LIGHTING SERVICE

11.1. AVAILABILITY:

This schedule is available for electric service to sport field lighting, holiday decorative lighting or similar nighttime temporary or seasonal use.

11.2. MINIMUM:

The net monthly minimum charge for any month during which electrical energy is used will be \$41.70.

11.3. ENERGY COST RECOVERY:

The above energy charge will be adjusted in an amount provided by the terms and provisions of Rate Schedule 16, Energy Cost Recovery, Rider ECR.

11.4. CONSUMPTION:

Service will normally be delivered and metered hereunder at the secondary voltage available at the service location. Where physical circumstances would normally make it necessary to meter the service at primary voltage, the Company may at its option install a time clock in place of primary metering facilities to measure the hours-use of the service and compute the kilowatthours' consumption of the sport field by using the Customer's connected load. The connected load used for the calculation will be determined at the time of installation and at such subsequent times as the Company may deem necessary by actual load check of the Customer's facilities. Unmetered dusk to dawn service may be provided, in which case the connected load will be used to determine the kilowatt-hours consumed.

11.5. INSTALLATION CHARGE:

In addition to the above charge, a Customer of temporary nature will be required to pay the net cost of erection and removal of any special facilities necessary to provide service. Such net cost will include the Company's total expenditure for labor, material, supervision and all other costs necessary to erect and remove facilities for service, less proper credit for actual salvage.

11.6. PAYMENT:

Bills will be due on or before fourteen (14) days after the mail date of bill.
