12. MISCELLANEOUS SERVICE

12.1. AVAILABILITY:

This schedule is available for electric service to signal systems or similar unmetered service and to temporary or seasonal use.

12.2. MONTHLY RATE:

For all energy used, per kWh \$ 0.17918

12.3. MINIMUM:

The net monthly minimum charge for any month during which electrical energy is used will be \$41.70.

12.4. ENERGY COST RECOVERY:

The above energy charge will be adjusted in an amount provided by the terms and provisions of Rate Schedule 16, Energy Cost Recovery, Rider ECR.

12.5. CONSUMPTION:

The connected load will be used to calculate the kilowatt-hours consumed on unmetered service.

12.6. TRANSMISSION COST RECOVERY:

The above energy charge will be adjusted in an amount provided by the terms and provisions of Rate Schedule 15, Transmission Cost Recovery Rider, Rider TCR.

12.7. INSTALLATION CHARGE:

In addition to the above charge, a Customer of temporary nature will be required to pay the net cost of erection and removal of any special facilities necessary to provide service. Such net cost will include the Company's total expenditure for labor, material, supervision and all other costs necessary to erect and remove facilities for service, less proper credit for actual salvage.

12.8. PAYMENT:

Bills will be due on or before fourteen (14) days after the mail date of bill.

12.9. GROSS RECEIPTS, OCCUPATION OR FRANCHISE TAXES:

There will be added to the Customer's bill, as a separate item, an amount equal to the proportionate part of any license, occupation, franchise, or other similar fee or tax now or hereafter imposed upon the Company by any municipality or any other governmental authority, whether imposed by ordinance, franchise, or otherwise, in which the fee or tax is based upon a percentage of gross receipts, net receipts, or revenues from the sale of electric service rendered by the Company to the Customer. Bills will be increased the proportionate amount only in service areas where such tax is applicable. See Tax Adjustment Rider.

12.10. CONDITIONS OF SERVICE:

- 12.10.1. Service will be furnished for the sole use of the Customer and will not be resold, redistributed, or submetered, directly or indirectly.
- 12.10.2. Voltage, phase, and frequency of service supplied will be as approved by the Company.
- 12.10.3. Bills for service will be rendered monthly. Where service is for temporary use, the bill for the current month's service will be rendered immediately on discontinuance of service.
